#### What is a General Plan?

"The general plan is more than the legal underpinning for land use decisions. It is a vision about how a community will grow, reflecting community priorities and values while shaping the future."

~Office of Land Use and Climate Innovation (LCI), General Plan Guidelines





# Three Defining Features:

#### General

 A general plan provides general policy guidance that will be relied on to guide future land use and resource decisions.

#### Comprehensive

 Covers a range of topics, such as land use, housing, economic development, recreation, natural resources, and much more

#### Long-Range

• A general plan provides guidance on reaching a future envisioned 20 or more years in the future. To achieve the vision, a comprehensive plan includes goals, policies, and actions that address both immediate and long-term needs

### **General Outline of Planning Stages**

Informatio n gathering

Existing conditions Community vision, guiding principles, and goals

Draft preferred alternative/EIR **Alternatives** notice of analysis preparation and scoping

Draft General Plan/EIR

Final **GP/EIR** 

Adoption and approval

**Planning** team is assembled and background research is conducted

**Planners** compile a report that includes existing conditions through sites visits, surveys, focus groups, etc.

Community is encouraged to participate development of the vision

**Planning** Department (PD) presents various feedback obtained and selects the best possible option

PD begins GP Update and the environmental impact report (EIR) required by the California Environmental Quality (CEQA)

PD releases the preliminary draft GP and EIR for review

PD completes the update and EIR and public hearings are scheduled

GP and EIR go through hearing with planning commission and then before City Council or County BOS

**GP Advisory** Committee may be formed. **Participation** advantageous

Numerous opportunities for community engagement

Crucial opportunity Participate to ensure that the scenario selected takes into account your priorities

Attend the scoping session to request scientific study that would help understand impacts and significance of tobacco on the environment

Review relevant sections to ensure tobacco language is included

If you submitted comments to the PD. vou should have received a written response outlining agreement or disagreement on the comments.

Attend public hearings to ensure proposed policies are in place

to participate in this phase

# **Element Legal Requirements**

Applicable Element(s)	Land Use, Environmental Justice
Legal Requirement Summary	The primary function of the General Plan's <b>Land Use Element</b> is to lay out a pattern for a city or county's future development. It must address the type, intensity, and distribution of land uses within the jurisdiction and among other things, should be consistent with the natural resources conservation requirements of the Conservation Element. The Land Use Element should also reflect the community's vision; promote thoughtful, equitable, and accessible distribution of different land uses, including residential, commercial, industrial, agricultural and open space; and align well with other general plan elements."  Gov. Code § 65302(a).1
	The purpose of the <b>Environmental Justice Element</b> is for cities and counties to identify objectives and policies to reduce the unique or compounded health risks in disadvantaged communities, to promote civil engagement in the public decision-making process, and to prioritize improvements and programs that address the needs of disadvantaged communities. Reducing pollution exposure, promoting safe and sanitary homes, and reducing any unique or compounded health risks in disadvantaged communities are some priorities in this element. Disadvantaged communities are areas identified by the California EPA (see <a href="mapping tool">mapping tool</a> ) and any other area that is low-income and disproportionately affected by environmental pollution, other negative health hazards, or environmental degradation. <b>Gov. Code § 65302(h).</b> <sup>1</sup>





### Data, Studies, and Key Findings



#### **Evidence**

- Tobacco product waste aggregates where tobacco retail stores are sited.<sup>2,3</sup>
- Tobacco retail establishments are more densely located in low-income and communities of color.<sup>4,5</sup> These communities are disproportionately designated as disadvantaged communities as defined by Gov. Code § 65302(h)¹ due to their higher exposure to various environmental hazards.<sup>6</sup>
- Cigarette butts are made up of thousands of plastic microfibers that contain thousands of toxic and carcinogenic chemicals from commercial tobacco smoke, such as nicotine, pesticides, polycyclic aromatic hydrocarbons (PAHs), arsenic, and heavy metals such as lead and cadmium.<sup>7</sup>

### **Best Practice Language**

**Best Practice Language** 

**Designates Endgame** 

© Goal: Phase out all commercial tobacco sales.

- **Policy** Adopt an ordinance prohibiting any commercial tobacco sales by [date].
- **Policy** (for jurisdictions with an existing TRL): Adopt an ordinance prohibiting the issuance of any new tobacco retail licenses; discontinue any renewals by [date].
- **Policy:** Remove any existing land use designation that permits tobacco retailer establishments.

**Goal:** Reduce tobacco retailer proximity to and density near open space and disadvantaged communities.

**Policy:** Restrict New Commercial Tobacco Retailers. Discourage new tobacco retail establishments (i.e., smoke shops, vape shops, grocery stores that sell tobacco products) to prevent addiction, encourage cessation, and reduce exposure to environmental hazards.

**Policy:** Cap the number of licenses issued in regions that meet the definition of "disadvantaged communities." Licenses may be capped at zero (0), meaning no new license shall be issued.

Policy: Prohibit tobacco retailers from being located within one thousand


