

Collaborative, on **Wednesday, December 10, 2025, 10:00 AM – 11:00 AM**, for a training on their policy platform update, **RISE 2025 Policy Platform Update: Leading with Tobacco Treatment**. Attendees will learn about the recent updates and how to incorporate recommendations into current and future work plans.

The RISE policy platform, **Reducing the Impact of Tobacco on Rural California Communities: A Policy Platform**, is a tool rural projects can use to strengthen tobacco treatment capacity and advance policy efforts across rural communities. This training will offer clear guidance and examples from rural settings and is for all rural tobacco prevention staff at any stage of project and policy campaign development.

The training session will walk participants through what was updated since RISE's first policy platform (2021) and why and highlight the increased importance of centering tobacco treatment in policy planning. It will include information on the four rural priorities for policy and systems change and practical strategies to integrate into project work plans that reflect rural contexts, resource realities, and local partnership structures.



Health & Well-being in Rural Northern California: Reducing the Impacts of Tobacco Use

The California Center for Rural Policy (CCRP) is launching the first in a series of virtual informational sessions on health disparities in Rural Northern California. In this series, they ask a critical question: Why are people in Rural Northern California dying too early?

Drawing on CCRP's late 2024 analysis, they identified three major risk factors driving disproportionate negative health outcomes in the region:

- Tobacco use
- Substance use
- Mental health challenges

The first session will focus on tobacco use as a key contributor to premature death and poor health outcomes. They will explore local data, share evidence-based practices, and discuss actionable strategies communities can use to protect and reduce the impacts of these health disparities for Northern California residents.

Statewide Retail Endgame Progress

- Nov 2025 - Ross - Bans the sale of all tobacco products (Eff. Dec 2025)
- Nov 2025 - Tiburon - Bans the sale of all tobacco and vape products (Eff. Dec 2025)
- Sep 2025 - Ceres, CA - Bans all electronic smoking devices and paraphernalia
- Sep 2025 - Capitola - Bans all filtered cigarette sales (Eff. Jul 2027)
- Jun 2025 - Santa Cruz - Bans all filtered cigarette sales (Eff. Jan 2027)
- Oct 2024 - Santa Cruz County - Bans all filtered cigarette sales (Eff. Jan 2027)
- Feb 2020 - Manhattan Beach - Bans all tobacco and vape products (Eff. Jan 2021)
- Jun 2019 - Beverly Hills - Bans all tobacco product sales* (Eff. Jan 2021)

Advancing Rural Tobacco Prevention: A Thought Leaders' Summit

UPDATE - Held near Mount Shasta on November 6-7, 2025, RISE and TRDRP hosted a convening of tobacco prevention and treatment leaders for the express purpose of learning the current landscape of rural tobacco and nicotine prevention and treatment and brainstorming best cross-sector approaches and steps to continue to reduce the disparity of rural tobacco use and treatment.

A summit brief, under development by the California Center for Rural Policy (CCRP), will be released in January along with more details of the gathering.

The UCSF Smoking Cessation Leadership Center recently hosted an engaging webinar with Timothy McAfee, MD, MPH, Professor in the Department of Behavior & Social Sciences at the University of California San Francisco; April Roeseler, BSN, MSPH, Former Branch Chief of the California Tobacco Control Program, in the California Department of Public Health Control; and Pamela M. Ling, MD, MPH, Professor of Medicine and Director of the Center for Tobacco Control Research and Education at the University of California San Francisco.

Hosted by Catherine Bonnoit, Executive Director of the Smoking Cessation Leadership Center, this webinar explores the risks of losing the national tobacco control program, the importance of sticking to our core values and objectives, evolving tobacco products, and cessation for young people. This webinar is a great opportunity to gather your coalition and learn about tobacco prevention history and where we may be headed within the current federal landscape.



New Policy Brief Series on Aging in Rural California Released

The SCAN Foundation, a national philanthropic organization working across sectors to address structural barriers and build more equitable systems for aging, released three new policy briefs to "provide legislators and advocates with clear, actionable recommendations to address the needs of rural older adults, a population that is growing rapidly and already straining under workforce shortages, housing insecurity, and health disparities."


While not specific to tobacco, the complexities of aging in rural California do impact access to treatment services.

Outdoor SHS Policy Coverage


